- Identify the key components and structure of an effective compliance management system.
- Understand the GACP principles and selected key standards, requirements and guidelines in applying the principles in respect of the following key compliance

management system components to:

- Design, implement and maintain a compliance management system to achieve sustainable compliance outcomes in the economic, societal and environmental contexts.
- Develop a compliance management system that is appropriate to the organisation's context and recognises, considers and prioritises the the legitimate and reasonable requirements, interests, expectations and concerns of relevant internal and external compliance stakeholders.
- Establishing appropriate governance structures and practices in accordance with leading governance practice for effective compliance oversight.
- Establish and maintain a suitable compliance policy and framework that provides the structure on which the compliance management system is built.
- Define the compliance roles and responsibilities of various role-players and ensure that these are implemented in a way that facilitates effective compliance management.
- o Define and promote an ethical compliance culture.
- Establish and maintain an independent compliance function with the appropriate status in the organisation.
- Adopt a compliance risk-based approach using clearly defined materiality levels to manage compliance risks in accordance with approved compliance risk appetite and tolerance levels.
- Use structured and systematic compliance planning in the implementation of the compliance approach, carrying out of compliance activities and meeting of compliance obligations.
- Designate a suitable head of compliance and ensure adequate and appropriate compliance resources.
- Develop a suitable compliance methodology and ensure the effective execution of the compliance process to identify, assess, manage, monitor and report on compliance risks and fulfil other compliance management activities.
- Enable effective compliance communication and reporting in respect of the compliance management system and the management of compliance risks.
- Establish a compliance quality assessment and improvement programme that will provide a mechanism to understand and improve the achievement of sustainable compliance outcomes and improve conformance with GACP principles and standards.
